He said this would link the monarchy more closely with India and would underline Britain's position as a world power. The Queen was pleased with this arrangement and saw India as a jewel in the crown of her empire, a place full of vibrant colors, gems, fruits and spices. As such Queen Victoriaviewed India as a land to be governed by British order and justice so that protection could be given to the Indian people against war, rebellion, famine and illiteracy.
